Governor Walz has proclaimed November as Native American Communities throughout Minnesota. Minnesota shares its geography with 11 sovereign tribal nations – four Dakota and seven Ojibwe. MNsure Open Enrollment Started This Week

The 2023 open enrollment period runs November 1 through January 15, 2023. With MNsure, Minnesotans can enroll in medical and dental plans for 2023 and access savings that reduce health care costs for individuals and families. The savings work like an instant discount to lower the cost of monthly premiums and are only available through MNsure; consumers can't access them anywhere else. Eligible Minnesotans are projected to save \$560/month or \$6,700/year, on average, when they purchase 2023 coverage through MNsure.

- Enroll by **December 15** to have coverage start January 1, 2023.
- Enroll by January 15 to have coverage start February 1, 2023.

Metro Transit staff will be <u>taking public comments</u> on the Draft Corridor Plan on the planned METRO F Line until **December 5.**

The <u>F Line</u> is a planned Bus Rapid Transit (BRT) line that will provide faster and more reliable transit service in the Route 10 corridor from downtown Minneapolis to Northtown Transit Center along Central Avenue, 53rd Avenue, and University Avenue. The F Line will be the sixth line within the Twin Cities region's BRT system.

2023 Invasive Aquatic Plant Management Grant Applications Open Deadline: December 12

The Minnesota Department of Natural Resources (DNR) offers grants to lake associations and other groups for invasive aquatic plant management projects.

Invasive aquatic plants are non-native plants that can potentially reduce native plant diversity and create recreational nuisance in lakes. The DNR's invasive plant management goal is to minimize harmful effects caused by invasive plants while also protecting natural resources and their use.

Applications will be accepted starting midnight **Thursday, November 10**. The application deadline is 9 a.m. **Monday, December 12**. Application materials and details about the grant program will be made available on the <u>DNR website</u> on **November 9**.
