The Governor and Lieutenant Governor are seeking qualified and diverse individuals who are passionate about using their knowledge, skills, and lived experiences to serve the State of Minnesota. State boards and commissions do important work that includes protecting the public, licensing and regulating professions, and advising policymakers. With over 100 boards and commissions covering topics from architecture to the zoo, there are hundreds of opportunities annually.

Ombudsman Volunteers Needed for Long-term Care

Before the COVID-19 pandemic, the Minnesota's Office of Ombudsman for Long-Term Care had 33 certified ombudsman volunteers statewide. Fast forward to the fall of 2022, and there are only 14 volunteer ombudsmen serving nearly 2,500 nursing care and assisted living facilities across Minnesota, and the ombudsman is seeking new volunteers across Minnesota. The volunteers are assigned to regional ombudsmen staff to ensure the health, safety, and rights of long-term care consumers.
